Frequently Asked Questions



WHAT IS THE SHIRE OF DANDARAGAN'S ECONOMIC DEVELOPMENT GRANT?

The Economic Development Grant invests in locally driven projects that contribute to economic development, delivering economic benefits within the Shire of Dandaragan.

Delivered locally by the Shire of Dandaragan, it is an annual competitive grants program.

WHAT CAN AN ECONOMIC DEVELOPMENT GRANT BE USED FOR?

The Economic Development Grant provides funding to support locally driven projects that will contribute to economic growth in the Shire of Dandaragan.

Grants of \$5,000 and up to \$30,000 are available for individual projects that promote increased jobs and sustainable workforce solutions, increased tourist visitation, productivity enhancements, business skills and building the capability of business, as well as stimulating new investment and industry growth, value adding and diversification of primary production in the Shire of Dandaragan.

The grant guidelines outline what funds can be applied to. Further clarification can be sought from the Economic Development Manager at the Shire of Dandaragan.

HOW CAN I APPLY?

DO I HAVE TO BE BASED IN THE SHIRE OF DANDARAGAN TO APPLY?

The Economic Development Grant is targeted at providing financial assistance to businesses and organisations based within the Shire of Dandaragan.

However, organisations outside the Shire may apply, but will need to demonstrate that significant economic benefit will be delivered within the Shire of Dandaragan and will need to show their commitment to local decision-making and planning.

HOW MUCH FUNDING CAN I APPLY FOR?

Applicants can request funding of \$5,000 up to \$30,000. Applicants are expected to make a contribution of 50% or more of the total project cost.

CAN MY ORGANISATION APPLY FOR FULL PROJECT FUNDING?

As outlined in the Economic Development Grant Guidelines, a minimum of 50% cash contribution is required from the applicant. Applicants are encouraged to leverage funding opportunities from multiple sources where possible.

WHAT IS THE CLOSING DATE?

Applications for the inaugural round of the Economic Development Grant open on Monday 3 July, 2023 and close at 5pm AWST on Thursday 31 August, 2023.

Grant applications must be submitted by:

- mail service, postmarked no less than five working days prior to the closing date,

WHAT IF I AM NOT REGISTERED FOR GST?

Applicants can still apply for a grant if they are not registered for GST concessions. Unregistered grant applicants must provide in their budget the amount of the grant **inclusive** of all project costs **including GST**.

If you are not registered for GST concessions and need further clarification, please contact the Economic Development Manager prior to submitting your application.

WHAT ARE 'PROJECT OUTCOMES'?

Outcomes refer to the intended economic benefits that are expected as a result of delivering the project with the grant funding. The outcomes you provide in your application should be realistic as you will be expected to report against these if successful.

The below table may be a useful tool to help applicants map the expected project outcomes and benefits for inclusion in the grant application.

These are examples. You will need to consider outcomes relevant to your project.

HOW ARE APPLICATIONS ASSESSED AND HOW SOON AFTER APPLYING WILL I KNOW IF I AM SUCCESSFUL OR NOT?

Staff from the Shire of Dandaragan will undertake a rigorous review of all applications, prior to them being presented to the Council for assessment. Applicants should allow two months from the closing date for the competitive assessment and selection process. This should be considered by applicants during project planning.

The selection criteria and decision-making process used to assess applications are outlined in the Grant Guidelines.

HOW MANY APPLICATIONS WILL BE AWARDED WITH A GRANT?

There is no set number of successful applications. There may be one, or there may be more. However, there are limited grant funds of \$30,000 available per year.

IF I AM UNSUCCESSFUL THIS ROUND, CAN I APPLY AGAIN WHEN THE NEXT ROUND OPENS?

Unsuccessful applicants can contact the Shire of Dandaragan to discuss the outcome of the selection process and how the application might be amended for consideration in a future grant round.

WHEN IS THE NEXT ROUND?

The Economic Development Grant will be offered by the Shire of Dandaragan on an annual basis. The next grant round will open early in 2024 and be awarded by June 2024 for expenditure in the 2024/2025 financial year.

The Grant will be advertised by direct email invitation to businesses that have lodged a prior EOI with the Shire. In addition, the Economic Development Grant will be advertised on the Shire of Dandaragan website, in the monthly Shire Matters newsletter, and via posts on the Shire's Facebook page.
