SuperTowns Update - Civic Building Progress

Most of you would have noticed that some action is occurring in the middle of town where the new civic building will be built under the (Royalties for Regions funded) SuperTowns Program and construction is due to start in the coming months. Pindan have already fenced off the construction site and site offices delivered. During the construction period I ask for the community's patience as various parking and other arrangements will be affected.

The community and Council has accomplished a lot when we look back over the previous 18 months from the planning and Business Case processes to the awarding of the construction tender.

History to date:

- 1. Community Reference Group was established and included key members from business, community and government to discuss the needs for the future of Jurien Bay and the region. Through this process, key recommendations were agreed upon which formulated the ranking of the proposed projects.
- 2. The Business Case for the "City Centre Enhancement Project" including estimated costs and building concept design was written and presented to state government after being endorsed by Council.
- Following the funding announcement by the state government (\$12.1m for Jurien Bay) a Project Steering Committee was established to discuss and provide input to the design of the civic centre building. Council was also represented on this steering committee.
- 4. Throughout this process extensive public consultation was carried out.
- 5. A Design Brief was written and endorsed by both the Project Steering Committee and the Council.
- 6. The Architect prepared a design and following numerous meetings, a final design was endorsed by both the Steering Committee and the Council.
- 7. Council then appointed E-Space, an interior design company to assist with the theme and layout of the internal spaces of the building. This was also endorsed by Council and work continues on this today.
- 8. The tender documentation was prepared in accordance with the adopted concept plan and this was made available to interested parties. The tender documentation also encouraged the use of locally based contractors.
- 9. Tenders closed in September 2013 and a successful tenderer (Pindan) being endorsed by Council in October 2013.
- 10. Demolition of the old Shire office will commence in November with construction of the new building commencing in the New Year.

This is a short summary of the progress to date. Regular updates will be provided in the future. No doubt you will start to see a lot of activity on the site in the next few months.

New website revolutionises our view of WA

On 29 October 2013 Minister for Lands, Brendon Grylls launched a new website that brings together information on property boundaries, public transport networks, the location of schools, health services and the latest census data. It will also provide satellite updates on the location and intensity of fires across Western Australia.

Mr Grylls said the website, LOCATE provided access to comprehensive government – sourced data and imagery.

Locate will put information at the fingertips of home buyers, real estate investors and developers to help them make informed decisions when purchasing property. It also provides historical maps dating back to the 1800's of Perth and country towns, along with aerial photography of the State that can be layered over Landgate's most recent aerial imagery.

This is critical information for emergency services, farmers and land management professionals in discovering, tracking and managing fires. It can also help residents make decisions if a fire is near their home.

JURIEN BAY SNORKEL TRAIL

The reef itself is essentially complete with only a small number of reefballs to be finally positioned.

Marine growth is already establishing itself on the reef, at this stage mainly algal growth, but this will be an attraction to other forms of marine life. A Lion Fish and a Banded Sweep have taken up residence and this is an encouraging sign for the future.

A signage and seating area has been constructed at the end of the sea wall near the reef and temporary information signs were installed last week.

An information flyer and a waterproof dive card have been printed and these will be available from selected outlets in town. They will indicate the type of marine life that a diver can expect to see and will be updated at regular intervals, as more life colonises the reef structure.

The reef area is covered by a 'No Powered Vessel Zone' and a 'No Fishing Zone'.

IMPLEMENTATION CAT REGISTRATION FEES & CHANGES TO DOG REGISTRATION FEES

As of the 1 November 2013 all Cats are required to be Micro-chipped, De-sexed and Registered.

Lifetime registrations for dogs can now be taken / accepted.

The proposed fees for Cats & Dogs are as follows:

PLEASE NOTE:

The Amendments to the *Dog Act 1995* were passed by Parliament on 24 October 2013 and you now have the option to register or renew your Dog for a Lifetime. From the 1 November 2013 all new dogs, that is pups and other dogs being registered for the first time will need to be micro-chipped. All dangerous dogs will have to be micro-chipped by 30 November 2013. All other dogs do not have to be micro-chipped until 1 November 2015.
