#### FROM THE CEO'S DESK....

Every two years Local Government in Western Australia sends itself into a spin with the elections being held in October. This year's election was once again undertaken by the Western Australian Electoral Commission and Returning Officer Peter Lyons. As with previous elections, compared with the State average, the Shire of Dandaragan performed extremely well.

Our Shire received a 48.88% turnout rate for the 2015 Election, compared with the State average of 27.5%. We also had 10 quality candidates put their hands up for the six positions that were available. Secretly, all of us involved with the election were hoping for a 50% plus turnout rate!

The Statewide results also indicated an increase in participation of women nominating for Council, and this was also the case at Dandaragan. The Dandaragan Shire Council now has 4 of the 9 Councillor positions held by female Councillors.

The Council held its first meeting following the election on the 22 October 2015. As a number of media reports have stated, the Shire Council elected its very first female President in Cr. Leslee Holmes. Leslee brings with her a wealth of experience particularly in the areas of tourism, small business, community and economic development. Leslee is also joined by recently elected Deputy President Cr. Darren Slyns. I am sure the new leadership team of Leslee and Darren will bring a number benefits and opportunities to the Shire of Dandaragan into the future.

I would also like to congratulate our newly elected members of Kaye McGlew (re-elected) Dahlia Richardson, Wayne Gibson (re-elected), Chris Carey and Peter Scharf. However, in particular I would sincerely like to thank Cr. Gibson for his efforts in leading the Shire as its President since March 2013. Cr. Gibson was elected to the position of President following the election of Shane Love MLA into the State Parliament. He was once again re-elected to the position of President following the Ordinary Election in October 2013.

Wayne has worked tirelessly within the community to ensure that the ratepayers voices were heard, and implemented a number of initiatives to help improve the way the Shire carried out its duties. On behalf of the community, I would like to thank Wayne for his commitment to the Shire. I would also like to thank Wayne for the close working relationship we formed within our roles over the previous 2 years. Wayne continues to serve you all as a Councillor and has retained a number of key committee positions that will provide experience and continuity in the years to come.

Thank you also to Cr. Kaye McGlew who served as your Deputy President during the same period. Kaye has particularly been a strong voice for the rural communities as well as providing great direction and support in the education, community and youth areas.

And last, but certainly not least, I would like to thank Lawrie Short. Lawrie has been a Councillor for the Shire of Dandaragan between 2001 and 2015. Without a doubt, Lawrie is passionate and a fantastic promoter of the Shire of Dandaragan. He served as your Deputy Shire President between the years of 2003 – 2013 as well as a stint on the State Council. Unfortunately Lawrie was not successful in his bid for re-election this year, but his commitment to his Shire will certainly not go unnoticed. Thank you Lawrie, from all the staff and Councillors at the Shire for your dedication and friendship during your time.

As the election period draws to a close, I urge you all to make yourself familiar with your Councillors and introduce yourselves. Your Councillors volunteer their time to make our Shire a better place to live, work and play and I am sure they would appreciate any feedback you may have.



# FOR ALL DOGS COMMENCED 1 NOVEMBER 2015

Amendments to the Dog Act 1976 made in November 2013 provided that from 1 November 2015 the owner of a dog that has reached three months of age must ensure that the dog is microchipped.



A dog is exempt from the microchipping requirement if a veterinarian issues a Certificate stating that the implantation of a microchip may adversely affect the health and welfare of the dog. The certificate cannot apply in respect of a dog that is under three months of age.

When a person registers their dog, they will be required to provide proof that the dog has been microchipped by providing their local government with the microchip number.

### **Shire of Dandaragan Elects President and Deputy President**

At a Council Meeting held 22 October 2015 at the Shire of Dandaragan, Councillor Leslee Holmes was elected to the position of President with Councillor Darren Slyns elected as Deputy President.

The appointment to President and Deputy President is a first for both Councillors and the first time in Shire of Dandaragan history that a female has held the President's position.

Together with Cr Holmes and Cr Slyns, Cr Gibson and Cr McGlew remain on Council with sitting members Cr Mike Sheppard and Cr Judy Kulisa. Three newly elected Councillors were also sworn in at the meeting, being Councillor Peter Scharf, Councillor Dahlia Richardson and Councillor Chris Carey.
