The Strategic Community Plan provides Council with its strategic direction within the region over the next 10 years and community consultation is an important part of this process.

Following this evenings workshop in Cervantes, I will update residents through my next Shire Matters President's Report on the next steps as we work towards finalising our Strategic Community Plan review.

### NOTICE TO ALL OWNERS AND OR OCCUPIERS OF LAND WITHIN THE SHIRE OF DANDARAGAN RESTRICTED BURNING PERIOD

Please be advised, the Shire of Dandaragan has entered the **Restricted Burning Period** As of 16 March 2016. Permits to burn **ARE REQUIRED** during the Restricted Burning Period up to and including 31 March 2016.

**A permit to burn must be obtained from your Local Fire Control Officer during the restricted burning period.** Permits are subject to a number of conditions but will NOT be issued for burning on Sundays or public holidays, unless approved by the Chief Bush Fire Control Officer.

If the fire danger forecast for the day issued by the **Bureau of Meteorology** is forecast for **VERY HIGH** or above, all permits are cancelled and the burn cannot be implemented.

## KS KIDSPORT

Registrations for football, netball and the winter sports will be opening soon. This is an opportune time to remind people of the availability of Kidsport funding for young people.

KidSport enables eligible Western Australian children aged 5-18 years to participate in community sport and recreation by offering them financial assistance towards club fees. The fees go directly from the local government to the registered KidSport clubs participating in the project.

Kidsport is now going online so applicants can complete the application form on line and upload a scanned copy of their concession card. The application will then be processed and the club informed of the approved Kidsport vouchers. The clubs can then invoice the Shire for items such as membership fees and uniforms.

## ONLY WORKING SMOKE ALARMS SAVE LIVES

Every year on April 1, April Fools' Day remember to change your smoke alarm batteries, using a high-quality, long-life battery



Fires can start quickly and without warning, every year more than 1500 house fires start in Western Australia causing millions of dollars damage. On average five people die in these fires. The risk of death from fire is three times higher in homes without smoke alarms.

A working smoke alarm can provide valuable minutes in detecting a fire, allowing you more time to escape safely and giving firefighters a greater chance of protecting your home.

You should only install smoke alarms that comply with Australian Standard 3786 and carry the Australia Standards or Scientific Services Laboratory (SSL) labels. Smoke alarms should be installed by a licensed electrical contractor in accordance with the provisions of the Building Code of Australia.

### Mains powered smoke alarms are now law

Since 1997 all new houses being built or undergoing major renovations require mains powered smoke alarms to be installed. In October 2009 new laws came into effect requiring homes built before 1997 to have mains powered smoke alarms installed when they are sold or rented to new tenants. Mains powered smoke alarms must be installed by a licensed electrical contractor. As of 1 October 2011 all rental properties are required to have mains powered smoke alarms.

### Smoke alarms for the deaf or hard of hearing

## ADDITIONAL RECYCLING WASTE COLLECTION TRIAL OVER EASTER SCHOOL HOLIDAYS

During the Easter and April School Holidays of 2016, the Shire of Dandaragan will be trialling a weekly Recycling Waste Collection Service throughout Jurien Bay, in addition to the normal fortnightly service. This will run from Monday 21 March through to Tuesday 26 April inclusive. Normal services will resume as of Monday 2 May 2016. The proposed Recycling Waste Collection schedule will be as follows:

21 March	Jurien Bay East & Cervantes	Jurien Bay West & East and Cervantes
28 March (Easter Monday)	Jurien Bay West	Jurien Bay West & East

11 April (School Holidays)	Jurien Bay West	Jurien Bay West & East
18 April (School Holidays)	Jurien Bay East & Cervantes	Jurien Bay West & East and Cervantes
25 April	Jurien Bay West	Jurien Bay West & East and Cervantes
2 May	Jurien Bay East & Cervantes	Jurien Bay East and Cervantes (as per normal)

During this time the Shire and its waste collection contractor, Avon Waste, will be collecting data. If the demand for these additional services is such, the Shire will investigate the merit of continuing the additional weekly recycling collection services within Jurien Bay and potentially across other parts of the Shire over the busy tourist periods of Christmas, New Year and Easter on a permanent basis.

Should any commercial operators within Jurien Bay, potentially require an additional weekly normal waste collection service (ie bi-weekly with an additional service on a Friday) during this period, please directly contact the Shire's Executive Manager Infrastructure on 9652 0800 to discuss these potential additional services and subsequent commercial arrangements.
