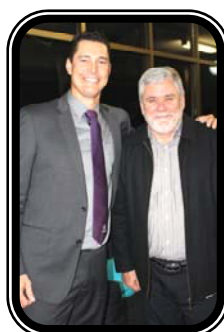

2017/2018 ANNUAL BUDGET

The Shire of Dandaragan Annual Budget for 2017/18 was adopted at the 27 July 2017 Council Meeting.

The Shire's total budget is \$20.7 million which comprises \$6.03m in capital works and \$14.6m in operating expenditure. Other than roads, this year's major capital project is the upgrade to the Cervantes Community Recreation Centre.

The 2017/18 budget allows for continued support toward existing community-based projects and organisations such as the Shire's Community Grants Program; Leeuwin Adventure Scholarship; Youth Services (which has a focus on Leadership and Youth Development), in addition to financial contributions to the Indian Ocean Festival and Jurien Bay Youth Group.

Other budget highlights include:

- New playground at Cervantes Recreation Reserve
- Carpark lighting at Badgingarra Community Centre
- Replacement of Dandaragan Cemetery gates
- Drawings and design for disability beach access
- Archaeology excavations at North Head Radar Site
- Outdoor shower at Thirsty Point
- Mezzanine carpet replacement at Badgingarra Community Centre
- Carpark upgrade at Cervantes Community Centre
- Toilet revision at Dandaragan Community Centre.

LOCAL GOVERNMENT PROPERTY LOCAL LAW

Please be advised that the Shire of Dandaragan has made a determination under Part 2 of the Local Law to provide that a person is prohibited in accordance with Clause 2.8(1)(c) from taking, riding or driving a vehicle on the property or a particular class of vehicle on the Turquoise Way Path (the property) within Reserves 28541, 51200, 49751 and 19206 and Lot 290 on Deposited Plan 31863. The prohibition applies to an area of the property 5 metres each side of the centre line of the path. The determination has effect on and from the date of publication of this notice.

ABOUT FOOD ALLERGY

What is food allergy?

A food allergy is an immune system response to a food protein that the body mistakenly believes is harmful. When the individual eats food containing that protein, the immune system releases massive amounts of chemicals, triggering symptoms that can affect a person's breathing, gastrointestinal tract, skin and/or heart.

Signs and symptoms of food allergy can be mild, moderate or severe. An allergic reaction can include; hives, swelling of the lips, face and eyes, abdominal pain, vomiting, swelling of the tongue, swelling of the throat, breathing difficulty, persistent dizziness and/collapse. If left untreated, signs and symptoms related to breathing and heart/blood pressure can be fatal.

What is anaphylaxis?

Food allergies can be severe, causing potentially life-threatening reactions known as anaphylaxis. Anaphylaxis must be treated as a medical emergency, requiring immediate treatment and urgent medical attention. Anaphylaxis is a generalised allergic reaction, which often involves more than one body system (e.g. skin, respiratory, gastro-intestinal and cardiovascular). A severe allergic reaction or anaphylaxis always involves the respiratory and/or the cardiovascular system. An allergic reaction usually occurs within 20 minutes to two hours of eating even a small amount of the food, and can rapidly become life threatening.

There are more than 170 foods known to have triggered severe allergic reactions. The most common triggers, causing 90 percent of allergic reactions in Australians are egg, cow's milk, peanut, tree nuts (such as cashew and almond), sesame, soy, wheat, fish and shellfish. Children often outgrow cow's milk, egg, soy and wheat allergies during childhood. Common life-long allergies include peanuts, tree nuts, sesame and seafood.

It is important to understand that in some people even very small amounts of food can cause a life-threatening allergic reaction/anaphylaxis. Some extremely sensitive individuals can react to just the smell of particular foods being cooked (e.g. fish) or even kissing someone who has eaten the food they're allergic to.

Currently, there is no cure for food allergy. Avoidance of the food is the only way to prevent a reaction. When a severe reaction does occur, adrenaline (epinephrine) is the first line treatment for severe allergic reactions and can be administered via an adrenaline autoinjector called the EpiPen®, which is currently the only available adrenaline autoinjector in Australia.

Other causes of anaphylaxis include:

Bites and stings - Bee, wasp and jack jumper ant stings are the most common triggers of anaphylaxis to insect stings. Ticks, green ants and fire ants can also trigger anaphylaxis in susceptible individuals.

Medication - Medications, both over the counter and prescribed, can cause life threatening allergic reactions. Individuals can also have anaphylactic reactions to herbal or 'alternative' medicines.
