### Declaration

2. I have applied to the Shire of Dandaragan for permission to live in temporary accommodation and live in the house when it is complete.
3. I understand the Shire may grant approval for me to live in the temporary accommodation for a period of twelve (12) months commencing on \_\_\_\_\_ and expiring on \_\_\_\_\_.
4. I will cease to live in the temporary accommodation at the end of that twelve months unless I am granted an extension of time (up to a further twelve months) in which to complete the dwelling.
5. I understand that no extension will be granted unless considerable progress has been made towards completion of the dwelling.
6. I understand that if I still require temporary accommodation beyond a twelve-month extension (twenty-four (24) months in total), I will need to make an application to the Minister of Local Government, Sport and Cultural Industries and I must have this approval before the expiration of my Temporary Accommodation Approval with the Shire.
7. I will not occupy the temporary accommodation until:
  - a) Appropriate ablution facilities are approved by the Shire;
  - b) an effluent disposal system is installed and approved by the Shire meeting requirements under the Health (Treatment of Sewage and Disposal of Effluent and Liquid Waste) Regulations 1974; and
  - c) a building licence for the proposed dwelling is issued (applicable to dwellings within a townsite).
8. I am aware that it is on the basis of my above declarations that the Council may grant approval of my application to occupy the temporary accommodation and that in the event that I occupy the temporary accommodation otherwise than in accordance with the terms of my approval to occupy or any extension of it then court proceedings may be initiated by the Council and that the statements I have made in this statutory declaration may be tendered in evidence against me.
