## COMMUNITY SPORTING AND RECREATION FACILITIES FUND 2014 – 2015 FUNDING ROUND

The Department of Sport and Recreation (DSR) seeks applications from incorporated, not for profit community groups and local governments for financial support through the CSRFF.

The purpose of this program is to provide Western Australian Government financial assistance to community groups and local government authorities to develop basic infrastructure for sport and recreation.

Applications must be submitted to local governments by the applicant prior to **Friday 30 August 2013** and subsequently lodged to DSR by **Friday 27 September 2013** following local government assessment and Council endorsement.

Projects must have a value of greater than \$150,000 with the maximum grant available being \$3,000,000.

To be eligible, prospective applicants must contact their local government authority or DSR regional office to obtain an application form and discuss their eligibility for funding, advice and assistance in preparing their submission.

## SHIRE OF DANDARAGAN

### ENROLLING TO VOTE FOR LOCAL GOVERNMENT ELECTIONS

Local government elections are scheduled for 19 October 2013. To ensure eligibility to vote please see table below.

<b>My circumstances are -</b>	<b>Do I have to apply to be on the roll?</b>
You live in the district (or ward) and are on the State Electoral roll.	No need to apply.
You live in the district (or ward) and are not on the State electoral roll.	Yes - get a form from any post office or the WA Electoral Commission and get the form back to them.
You are not an Australian Citizen but were on the Local Government electoral roll in 1996 and have owned or occupied rateable property in the district since then.	Yes — see how to apply below.
Your property is rateable and is owned or occupied by more than two people or by a company.	Two people only who are not already on the Local Government roll for the district (or ward) must be selected by a majority of the owners or occupiers or the company. They must be on the State or Commonwealth roll to be eligible. If more than one property is involved the same two people must be nominated for all the properties
You own property that is rateable in the district (or ward) and you are on the State or Commonwealth electoral roll but you live elsewhere.	Yes — see how to apply below.
You have a right of occupancy of property in the district (or ward) that is rateable and you are on the State or Commonwealth electoral roll but live elsewhere.	If you have a right of continuous occupation under a lease, tenancy agreement or other legal instrument for at least the next 3 months following the date you apply you should make an application - see how to apply below.

#### HOW TO APPLY

You can get an Enrolment Eligibility Claim form from any local government office. To be able to vote for this election your application must reach the undersigned by 5.00pm on 30 August 2013. Those nominated by a company must attach the letter of nomination to the form.
