### Applications close 30 April 2014.



#### SANDY CAPE ROAD ACCESS

Approval has recently been granted for road trains to use the Sandy Cape Road for the cartage of limesand to rural areas of this and other Shires to the east. Strict conditions apply to the use of the road including a 40km/h speed limit and that the trucks cannot use the road on public holidays, weekends adjoining a public holiday and the first and last weekend of the State school holiday periods. Council is very aware of the possible conflicts between tourist traffic going to Sandy Cape and heavy vehicles and it is the responsibility of the individuals using the road to take due care. This matter will be reviewed later this year.

### **RECYCLING MATTERS**

The agreed target for recycling rates in regional Western Australia by 2015 is 30%. So how does the Shire of Dandaragan compare to this goal? In February 2014 our figures show just over 23% of total kerbside collection waste was recyclables.



There is a misconception that because one truck collects both bins it means everything ends up in landfill. Our contractor AVON WASTE has dual-compartment trucks that keep rubbish and recyclables separate. All recyclables are taken to their Recycling Transfer Station in York.

The following items should be put into the yellow-topped bin:

- · Glass bottles, jars and containers
- Plastic packaging (cool drink, juice, milk, food packets, marked 1,2 or 3)
- · Aluminium cans and foil
- Steel cans (food and pet food containers and *empty* paint cans)
- Aerosol cans
- Liquid paperboard (long-life milk and juice cartons)
- Paper and cardboard (boxes, newspapers, telephone books, office paper, glossy magazines)

The green-topped bins are for all kitchen waste and general household waste.

Please take your time to compare the amount of rubbish pick up to recycling pick up you have in your household and let's get to our 30% recycling target by 2015.

### **PROJECT SUMMARY:**

### CAP (COASTAL ADAPTATION PROTECTION) GRANT

- The Shire of Gingin, Shire of Dandaragan and NACC have been working through the first steps of a Coastal Hazard Risk Management and Adaptation Planning Framework (CHRMAP).
- This Framework helps local governments identify potential areas at risk to coastal erosion and coastal inundation over the next 30, 50 and 100 years.
- The process is recommended by the WA State Government under their revised Coastal Planning Policy, which was endorsed by the Minister for Planning in 2013.
- This is only the third partnership of local governments working on this process in WA.
   Others being the Peron Naturaliste Partnership (Rockingham to Busselton) and the
   Cockburn Sound Coastal Alliance (Fremantle to Rockingham). Working in partnership is
   quite a progressive move for the project partners involved and a smart one that helps the
   partners to leverage external funding where it might not otherwise be possible working
   individually.
- This partnership is supported by many government agencies, WALGA and Curtin University.
- Completed steps of the Framework so far include:
  - ⇒ Data and Information Gap Analysis
  - ⇒ Workshop with project partners and community representatives in Ledge Point (which some of the participants may have attended, one representative from each Coastcare Group and Ratepayer Association from Guilderton to Jurien Bay attended the workshop, in July 2013)
  - ⇒ Workshop Summary Report
- These documents and others related to the project, such as media releases, policy and scientific references, are all available for downloading through the Coastal & Marine section of the NACC website.
- The next phase of the Framework is the Coastal Hazard Mapping and Risk Assessment.
- Coastal engineers and specialists from GHD (consultants) are working with NACC and the Shires to map the coastal areas from Guilderton to North Head that are likely to be impacted by coastal erosion and coastal inundation over the next 100 years.
- This information will be used to:
  - ⇒ Identify the natural and man-made assets that are likely to be at risk to erosion and inundation over the next 100 years.
  - ⇒ Identify options for reducing risk to these assets, which might include accommodate risk, protect from risk or retreat from risk. Options will be integrated into Council operations through planning instruments such as town planning schemes and local planning strategies.
- The project should be completed in 2015.
- There will be opportunities for the community to be involved throughout the process.
- Coastal erosion and coastal inundation are natural processes that have been occurring for thousands of years (the shoreline of the NAR used to stretch all the way to the Abrolohos (for more information on our coast's formation, people could attend the NACC Coast and Marine beach monitoring project bus tour on April 4<sup>th</sup> with Bob Gozzard and Mick O'Leary).
- The project stretches from Guilderton to North Head / Jurien Bay because the landforms along this coastline are similar, in that they are low lying sandy coastal landforms. Similar landforms are useful for strategic planning. Whereas the coastline changes significantly from North Head, and this has been identified by geologists and coastal specialists as a separate coastal compartment that stretches all the way to North Geraldton (Drummond's Point), and is characterised by rocky outcrops and headlands (for more information on our coast's formation, people could attend the bus tour on April 4<sup>th</sup> with Bob Gozzard and Mick O'Leary).

#### GRANTS TO HELP RESTORE BANKSIA WOODLAND

Community groups interested in restoring banksia woodland in the greater Perth area are being invited to apply for funding to help enhance the habitat of rare species.

Environment Minister Albert Jacob said \$300,000 was available under the State Government's Banksia Woodlands Restoration Program to assist volunteers to manage and conserve important bushland.

"We are asking local groups to help restore banksia woodland in areas dominated by weeds which will improve the habitat for wildflowers and native animals," Mr Jacob said.

"The project will have a major role in reversing habitat loss and managing threats to banksia woodland in Perth over the next two years, particularly for the endangered Carnaby's cockatoo."

Grants range between \$5,000 and \$20,000 for projects undertaken between June 1, 2014 and September 30, 2016, with funding supplied in two instalments and administered by the Department of Parks and Wildlife.

"Some examples of suitable projects include weed management, revegetation works, fencing to limit vehicle access and grazing, Phytophthora dieback assessment and treatment and management of pest animals," Mr Jacob said.

The Minister launched the grants program last week at a special event to mark the 21st birthday of the Friends of Hepburn Heights and Pinnaroo group, which has used previous grants to help restore the park's banksia woodland.

"The wonderful work the Friends of Hepburn Heights and Pinnaroo group has carried out is a great example of how other groups can help restore important bushland," he said.
