I thought I would take the opportunity to correspond with you all from Cheltenham in the U.K. where I am visiting my mother for her 87th birthday. As you read on, the reasons for that decision will become clear.

My family all reside in Mallorca Spain where they have been living and working for the past 27 years. They have enjoyed a wonderful way of life thus far with my father passing away some 20 years ago after a great retirement in the sun.

However, in the past couple of years my mum has decided that she is bored with the Island way of life and wants to spend some of her remaining years closer to infrastructure and medical care unavailable in Mallorca. She missed the galleries and libraries, and all the thing ladies love. We all thought the desire might wane when the reality of moving to another country at a late stage in life became apparent. Not so at all.

Never underestimate the strength of mind of the women in our family. My mother flew over last year, rented a lovely townhouse in a leafy lane in Cheltenham in Gloucester. She has furnished it with all new Laura Ashley, very English things and it really looks a treat. Her lovely home in Spain is now a memory and she doesn't want to bring much over. Who knows if she will wake up one day and decide to go back, open the shutters and resume life there. The fact she can still choose is so important.

I am in awe of my mother as she has very quickly found out where everything is and absolutely loves it. She is now feeling very independent without my sisters waiting on her and treating her like an old lady. She has volunteered for the Red Cross opportunity shop and is visiting the elderly in the local hospital. All this is done without a car as the Montpellier District is all walking distance. The doctor, who I am sure won't see much of her is just round the corner as is the dentist, hospital and other ancillary services.

Cheltenham is a very beautiful part of the world with great shops and cafés. Wonderful parks and gardens and lots of galleries and classy little pubs.

The train is close by and visits to family all over the country only take an hour or so and are really cheap and comfortable. Before any of you think about immigration I must tell you I have only listed the good bits.

The drawback is the horrible weather. I have been here for a week and 19 degrees is as much as it has managed to reach and that was only for a couple of hours one day. It rains every day and it is summer. I am cold most of the time and thanking god that I packed some warm clothes.

I hired a little car today and found out when we arrived home from a trip to the country for her birthday, that you can't park outside your own house. The tiny garage is too snug for me to risk as I was told and damage done will be charged to my card at £1000.00 and I can fight my insurance company for recovery. I parked outside the garage and a lurking parking inspector came out of the blue to tell me I needed a permit. I called the council and they told me I would be able to pay a visitors fee to park outside our own place which would be £20 a week.

All this seems so foreign to me with the free and wonderful life we lead. Even in winter in the Shire of Dandaragan it is warmer than this and the sky is blue. I never wear a raincoat from one year to the next.

The poor people here are so sick of waiting for summer that they have decided to wear their summer clothes anyway. Lots of pretty dresses and sandals in freezing cold wind. Lovely cafés that line the streets have breakfast diners jostling for outside tables in conditions that you would not go outside for at home.

On one of my many walks I noticed plenty of ladies carrying their grocery shopping home and climbing stairs into the many apartments in the middle if town. Husbands have long passed away and their lives do not seem lonely due to the activity created when people live close in to the city Center and not in suburbs miles away.

This has resonated with me very much as I don't think it is as simple as someone wanting to go back to their roots in their final years. Mum does not come from anywhere around here. I think it is a choice of where you want to spend your time and the quality of life you are seeking. It is easy for politicians at all levels to only talk about Aged Care and Hospitals when dealing with the older generation. No one really considers trying to create a great quality of life for the healthy ageing population.

After many great conversations that I have missed over the years, due to living so far away, I now have a much better understanding of the needs and aspirations of people of mums age group. I am acutely aware of the challenges we have in our part of the world to provide the things people would like so they can stay in the places they want to be.

### Shire to engage with Youth

## PLANT OPERATORS x 3

(Location - Dandaragan)

Applications are invited from interested persons for three positions as Plant Operators located in Dandaragan.

The three Plant Operator positions operate from Council's Operations Centre in the Dandaragan townsite. The successful applicants will work within a team that is engaged in a variety of tasks involving the construction and maintenance of Council's roads and other assets. The applicant should have sound skills and experience in heavy plant. The position of Plant Operator is required to hold a HC licence.

The position is classified as a Level 4 with an annual salary of up to \$49,915 per annum plus superannuation. The salary will be dependent upon qualifications and experience and is paid in accordance with the Local Government Industry Award 2010. Housing is available within the Dandaragan townsite at a subsidized rent amount and a water subsidy.

## FISH KILL - Jurien Bay Marina

On the 22 June a contractor reported a fish kill observed in the Jurien Bay marina to the Department of Fisheries (DoF). Approximately 500 individuals of various species we observed on or near the rocks lining the marina. Species included; blowfish; eels; blue swimmer crabs and; boxfish. Some fish were observed gasping at the surface and moribund.

On 23/06/2016 DoF officers collected fresh fish, preserved fish and water samples. Samples were delivered to the Fish Health group on to be processed for analysis.

Interim results were made available by the Department of Fisheries on the 1 July 2016:

- No HAB (Harmful Algal Bloom) species were present in the sample.
- Three formalin fixed fish were submitted for histopathology. Tissues of some of the fish show evidence of immunocompromisation prior to the fish kill event. It is highly likely that these fish were suffering from a chronic infection prior to the fish kill and the very low oxygen levels in the environment caused enough stress to kill the fish.
- One Trichodina parasite was also found in the gill cavities; this particular parasite is indicative of poor water quality.
- Bacteriology results Preliminary results show only one of the samples to have any bacterial growth.
   Further bacterial work up is being conducted.
- Water quality data Data provided by DoT indicates very low levels of dissolved oxygen in the marina.

<u>Conclusions:</u> Based on the available data it appears that fish in the immediate area may have already been immunocompromised and the very low levels of dissolved oxygen in the water contributed to the deaths. The low dissolved oxygen levels may be due to decomposition of seaweed which was washed into the marina by storm events.

### **ROYALTIES FOR REGIONS SEWERAGE PROJECT OPENING**

Recently the Shire of Dandaragan hosted the official opening of the Royalties for Regions funded Jurien Bay Sewerage Project.

Official guests included Mr Shane Love, MLA Member for Moore who officially opened the project on behalf of the Minister for Regional Development, Mr Terry Redman, MLA, and representatives of key stakeholders from the Department of Regional Development, the Wheatbelt Development Commission, Water Corporation and Councillors and senior staff from the Shire of Dandaragan.





President of the Shire, Cr Leslee Holmes stated that while not a particularly "sexy" project the delivery of this project does provide significant and important infrastructure services within Jurien Bay and will unlock development potential, both commercially and for the strategic growth areas of health and aged care and visitor servicing.

Funding for the Jurien Bay Sewerage Project was provided through various streams; Royalties for Region programs providing \$3.7 million as part of the Department of Regional Development SuperTowns fund

and \$1.06 million through the efforts of the Wheatbelt Development Commission in securing Growing our South funding. The Water Corporation contributed \$600,000 while the Shire of Dandaragan contributed \$300,000.
