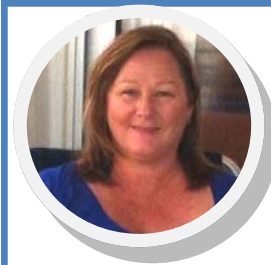

## PLANNING AND DEVELOPMENT ACT 2005

### LOCAL PLANNING SCHEME AMENDMENTS AVAILABLE FOR INSPECTION SHIRE OF DANDARAGAN LOCAL PLANNING SCHEME NO 7, AMENDMENT NO 27

Notice is hereby given that Landvision has prepared Scheme Amendment No 27 on behalf of the proponent (Mr D.G. Kent) to facilitate the subdivision of Lot 1 Jurien Road, Jurien Bay into 47 Rural Smallholdings lots ranging from 4 – 13.5ha, in addition to 1 lot containing the existing homestead and built infrastructure with an area of 46ha and 3 rural lots of 300ha each.

The Amendment initiation seeks to rezone and introduce various zoning controls in relation to the proposed Rural Smallholdings zone under the Shire of Dandaragan Local Planning Scheme No.7 (LPS 7).

The Scheme Amendment introduces appropriate management controls relating to land use, development, design of development and servicing to provide for a sustainable form of subdivision. Approval of a Structure Plan for the subdivision is to follow this Scheme Amendment.

Documents setting out and explaining the Scheme Amendment are available for viewing at the Shire Administration Centre in Bashford Street, Jurien Bay during normal opening hours. Submissions on the Scheme Amendments may be made in writing to be lodged with the undersigned on or before 4:00pm Friday 27 April 2018.

This Scheme Amendment is available for inspection in order to provide an opportunity for public comment and it should not be construed that final approval will be granted.

### SHIRE OF DANDARAGAN TEAMS UP WITH SHIRES OF GINGIN AND CHITTERING FOR NORTHERN GROWTH ALLIANCE

The Shires of Dandaragan, Chittering and Gingin have teamed up to form the Northern Growth Alliance and awarded a contract to Economic Transitions to develop a tourism strategy for the region.

The mission of the Northern Growth Alliance is to create a united approach to key strategic issues in the region.

The group works together to address shared problems, issues and challenges, to advance the interests of the region, develop and implement resource sharing strategies, work on regional service delivery models and undertake studies to address industry development and growth. The aim of the Alliance is to plan for future growth and to promote the region to investors, businesses, tourists and locals as an accessible and vibrant region with a strong economic future.

The Alliance was awarded a grant through Community Chest Funding from Wheatbelt Development Commission and is supported by Royalties for Regions through the Government of Western Australia.

Economic Transitions has been awarded a consultancy to assist the Alliance with the development of a tourism strategy for the region – from research and strategic planning, to marketing and business plans. They will be working with the group to develop a sub-regional action plan which will help address current and future tourism needs. 'They will undertake research to understand the region and its current tourism offering, look at opportunities for new development or growth, and suggest business models and planning tools which can help the regions work together to maximise their potential'.

The region is home to some of the best tourist attractions in our state; from the Pinnacles to sand-boarding in Lancelin, the beautiful beaches of Jurien Bay, the rolling hills of the Chittering Valley, carpets of wildflowers, gorgeous countryside and hidden gem wineries. By working together, our three Shires can really maximise our publicity and encourage more people to visit this beautiful region.

With the recent release of the 2017 Shire of Dandaragan community survey results that identified industry and jobs as a key issue for our residents, we are pleased that this Alliance will continue to develop new opportunities for jobs in tourism and associated industries within our communities.

## COUNCIL APPROVES AMENDMENTS TO YANDIN WIND FARM PERMIT

With the Shire's ongoing support of renewable energy, and continued advancement in wind turbine technology, Council approved a request at the January Council Meeting to increase the maximum allowable height of wind turbines at Yandin Wind Farm in Dandaragan. Amendments to the current planning permit were approved at the Ordinary Council Meeting which will allow for an increase in the height of the turbines from 152 to 180 metres. This increase will make way for more modern models to be installed which are generally more efficient, quiet and cost effective, as well as additional electricity generated from the site being maximised. A thorough consultation process took place which gave local residents and other stakeholders an opportunity to air concerns or support. Photomontages providing a visual representation of the impact of the increased height were shown to Councillors and nearby residents, and the amendments received unanimous support from Councillors.

## ADDITIONAL RECYCLE SERVICE ~JURIEN BAY

During the April and Easter Holidays of 2018 the Shire of Dandaragan will be again trialling a weekly Recycling Waste Collection Service throughout the Jurien Bay town site, in addition to the normal fortnightly service. This will run from the week beginning Monday 2 April 2018 through to and inclusive of Monday 30 April 2018. Normal services will resume as of week beginning Monday 7 May. The proposed Recycling Waste Collection schedule will be as follows:

Should any commercial operators within Jurien Bay, potentially require an additional weekly normal waste collection service (i.e. bi-weekly with an additional service on a Friday) during this period, please directly contact the Shire's Executive Manager Infrastructure to discuss these potential additional services and subsequent commercial arrangements.
